BUILDING PERMIT INFORMATION

Please contact building inspector for information regarding the project **before** any work is started. Some examples of required permits: re-roofing, re-siding, decks, swimming pool, garages, additions, inside remodeling, all sheds, driveways, fences, electrical and plumbing. Stoves, fireplaces, furnaces, and air conditioners also require permits. Property owners are responsible for securing permits and failure may result in more fees, fine or removal of the project. **IF IN DOUBT, CHECK.**

"9.05(18) Moving Snow Into Streets Ordinance

No Person shall clear snow from lots, parking areas, driveways, commercial areas or other places and pile or redistribute such snow in any public streets, roads or thoroughfares in any manner which in any way shall create a traffic hazard or impede snow removal or plowing of said public streets, roads or thoroughfares within the Town of Randall."

DOGS AND LICENSES

All dog licenses are issued for the *calendar* year for dogs 5 months or older.

Because of the numerous dog calls, the following ordinance will be more rigidly enforced.

(Dogs running at large)

(1) It shall be unlawful for any person owning or possessing any dog to permit the same to run at large without being attended by its owner or possessor. For the purpose of this section, the phrase "running at large" shall be defined to be the presence of a dog at any place in the Town, except on the premises of the owner or the premises of another with the consent of the owner or occupant of said premises. A dog shall be deemed to be attended by the owners or possessor if such dog is either on a leash or otherwise under the immediate control of the possessor or owner.

(2) Any person who shall violate this section, shall, upon adjudication to that effect, forfeit to the Town of Randall not less than \$25.00 nor more than \$50.00, as determined by the court in the action for the collection thereof, together with the costs of such act, and in default of payment thereof in the case of an individual, by imprisonment in the County Jail for Kenosha County, Wisconsin, for such time not exceeding ten (10) days as the court shall determine, unless the judgment is sooner paid.
